Crime

 On 09.06.2014 @ 10:00 Pm some persons working in Hotel R.K. City Hub, Police Bazar forcibly entered the Room No. 107 of the said hotel occupied by one woman aged 31 years by trying to enter through the ventilator, with the intent to rape her. However the lady locked herself in the bathroom and managed to inform her relatives over phone who in turn informed the Police.

The police immediately acted on receiving the information but were prevented from entering the building as the shutter was forcibly shut to prevent their entry. A forceful entry was made through the main entrance and arrested (1) Kajal Paul 22 years and four others namely (2) Belkish Reang 23 yrs (3) Bharat Jamatia 26 yrs (4) Md. Khaliuddin 26 yrs (5) Shiva Ranjan Ray 23 yrs. Sl No. (1) and (2) were the ones who tried to make a forceful entry through the ventilator, and Sl.No. (3),(4) & (5) prevented police from entering.

2. On 27.5.14, an FIR was lodged by one lady from Mylliem to the effect that she be friended one William through Face-book. He then enticed her to deposit sums of money into different accounts on different occasions which amounted to Rs. 3(three) lakhs. It was only then she realized that she had been cheated.

Immediately, the I.O of the case, Inspector B.K. Mishra, O/C Laban P.S., took up with the banks to freeze the different accounts where the victim had deposited the money. The I.O. managed to freeze an amount of about Rs.1(one) lakh. Then he started tracking the suspects and tracked them from different states in North East India to Sikkim to New Delhi. After a pain staking effort, the I.O. managed to arrest one of the account holders with the help of Delhi Police and brought her to Shillong on transit remand. The accused is one Miss Anju Gurung aged 26 years of Sikkim and working in New Delhi and presently is in Police remand. Other accused persons are still evading police arrest.

In this connection the district police would like to remind the general public especially females not to be enticed into depositing money with any strangers whom they friend through Internet. Though police is committed to arrest the accused persons inspite of all odds however, it will be unfortunate for the public to lose away money inspite of repeated warning from Police.
