- 3. Bidders or their authorized representatives are invited to be present at the time of opening of tenders.

B. TENDER VALUE

- 1. Not exceeding Rs.5,000/- = Rs.25/- only
- 2. Exceeding Rs.5,000/- but not exceeding Rs.50,000/- = Rs.50/- only
- 3. Exceeding Rs.50,000/- but not exceeding Rs.1,00,000/- = Rs.100/- only

4. Quotation

- 3. No modifications /changes in the Quotation(s) are permissible after opening of Quotations.
- 4. The selected Bidder(s) should supply all the items as per Supply Order to the consignee concerned within the stipulated period. In case of failure of the Supplier to supply wholly or partially the items requisitioned by the purchaser as per the terms & conditions, the Undersigned will be at liberty to order purchase of such items at the expense of the selected Bidder.
- 5. Once the rates quoted in tenders are accepted, no enhancement of rates will be allowed in any circumstances and the selected Bidder(s) will be liable to supply at the rates accepted by the Undersigned, failing which, the Contract will be cancelled and the Earnest Money shall be forfeited to the Government of Meghalaya

E. TERMINATION

The Undersigned may rescind / quash forthwith in writing if:

- 1. A Supplier assigns or sub-lets to any other supplier without his prior approval in respect of the Contract or any other Contract entered into with the Undersigned.
- 2. A Supplier or his agent/ staff / representative is guilty of fraud in respect of this contract or any other contract.
- 3. A Supplier declines, neglects or delays to comply with the demand or requisition or in any other way to perform or observe any condition of the Contract

In such cases, the Contract will be cancelled and the Earnest Money shall be forfeited to the Government of Meghalaya.

4. If a Supplier wilfully neglects, fails to perform or observe any condition of the Contract, or attempts to cheat or indulge in foul practices, the Undersigned has the right to impose a ban on such a supplier for future business with this office besides cancellation of Contract and forfeiture of the Earnest Money.
